Any preliminary matter not raised or filed seven days before the hearing date will not be allowed to be raised or filed thereafter, except by permission of the court for good cause shown. Motions not presented on or before the Pretrial Date are waived. Only an application for probation and the election of jury punishment are excepted and may be presented at the time of jury selection.

**JURY SELECTION – MONDAY, OCTOBER 22, 2018 at 9:00 A.M.**

The date for testimony to begin will be determined on the day of jury selection.

Cases ready but not reached for trial will be set on the next jury docket for that county.
