Hamilton County Commissioner's Court met in Special Session-Budget Workshop on Thursday, August 11, 2011 at 9:00 A.M. with the following members present: Commissioners Jim Boatwright, Mark Tafel, Jon Bonner and Dickie Clary. County Judge Randy Mills was absent (vacation).

The meeting was called to order by Commissioner Bonner and opened with discussion regarding the repairs sustained in the Hamilton County Courthouse due to flooding.

R&R Construction Randy Slazar presented his estimate for the water damage sustained to the Hamilton County Courthouse Annex Flood Damages in the amount of \$107,266.18. Belfor Property Restoration (Robert Owen Operator and Dave Davis-Estimator) also submitted an estimate for the damages in the amount of \$90,234.52. (Recorded in Commissioner's Court Papers Book 40 Page 456)

The court requested that County Clerk Debbie Rudolph send an email to Dana Farmer insurance adjustor to inquire about content manipulation regarding moving of the offices for this remodeling.

The court also asked Administrative Assistant Clydell Massingill to contact a plumber regarding an evaluation of the plumbing system so that this does not happen again.

The court took no action regarding a contract for repairs related to the flood damages.

The court then moved into budget workshop and went into Executive Session at 9:59 A.M. The court closed the Executive Session and reconvened into Special Session Budget Workshop at 10:20 A.M. The court recessed for lunch and announced that they would reconvene at 1:15. The court reconvened at 1:20 P.M.

The court recessed mid afternoon until Friday, August 12, 2011 at 9:00 A.M. to continue the budget workshop.
