Hamilton County Commissioner's Court met in Regular Session on Tuesday, December 8, 2015 at 1:00 P.M. with the following members present: County Judge Mark Tynes, Commissioners Johnny Wagner, Keith Allen Curry, Lloyd Huggins and Dickie Clary.

Tynes called the meeting to order and established that a quorum was present.

Clary led the invocation and Tynes led the pledges.

Richard Layne spoke during the public comments regarding agenda Item No. 11-Approve Appointment of County Public Information Officer stating that he has ask for a lot of public information in the past and has had no problem obtaining from each office the information he has wanted.

There were no line item transfers and budget amendments to be presented to the court.

A motion was made by Huggins and seconded by Curry to ratify the approval of May 24, 2016 Joint Primary Run-Off Elections. The motion carried unanimously.

Tynes replied to Layne's public comment regarding the Public Information Officer stating that some citizens don't know which office to go to request their information; there are emails received by the county that he was trying to see that they are routed to the proper office in a more expedient manner. He was trying to provide a better customer service to those individuals.
